

TERMS OF USE

BY (1) REGISTERING FOR AN EVEREST GROUP MEMBERSHIP, WEBINAR, OR EVENT (2) USING ANY EVEREST GROUP PLATFORM OR (3) ACCESSING THE EVEREST GROUP WEBSITE OR EVEREST GROUP PRODUCTS AND/OR SERVICES (together, (1) – (3), "Access"), YOU ARE AGREEING TO ALL OF THE TERMS CONTAINED HEREIN AND ARE REPRESENTING THAT YOU HAVE READ AND UNDERSTOOD SUCH TERMS. YOU MAY ALSO AGREE TO THESE TERMS THROUGH CLICKBOX ACCEPTANCE OR ANY OTHER DEMONSTRATION OF ASSENT INCLUDING EXECUTING A DOCUMENT WHEREBY THESE TERMS ARE INCORPORATED BY REFERENCE.

- a.
