



WHAT ARE THE PEAK MATRIX SERVICE PROVIDER OF THE YEAR™ AWARDS FOR IT SERVICES?

In 2022, Everest Group published 34 PEAK Matrix® IT services evaluations featuring 138 service providers across all evaluations. To recognize consistent top performers across PEAK Matrix assessments, we publish the PEAK Matrix Service Provider of the Year Awards. This is the eighth edition of the PEAK Matrix Service Provider of the Year Awards.

WHY THE PEAK MATRIX SERVICE PROVIDER OF THE YEAR™ AWARDS?

Everest Group PEAK Matrix evaluations are a valuable resource for IT services buyers to evaluate, compare, and contrast key service providers in the global services space. These assessments offer service provider selection guidance, as well as nuanced insights into these providers' strategies for key business lines, geographies, and technologies.

While there are service providers that feature as Leaders, Major Contenders, or Aspirants, and Star Performers on individual evaluation categories, there are some that exhibit consistent leadership and top performance across many different categories. As today's enterprises navigate the complex landscape of next-generation and legacy technologies, a global business footprint, and a complex provider portfolio, the PEAK Matrix Service Provider of the Year Awards help them to identify the best of the best – service providers with strong broadbased capabilities and successful services strategies that align well with the evolving enterprise IT demand.

HOW ARE THE PEAK MATRIX SERVICE PROVIDER OF THE YEAR™ AWARDS EVALUATED?

We use the following evaluation criteria to determine the Service Provider of the Year Awards:

- ITS Top 20 list: We create the list using a consolidated score reflecting points received on individual evaluations based on tiered scores for Leader, Major Contender, and Aspirant, and Star Performer positions
- Individual category awards: We base these awards on the count of Leader and Star Performer positions across the categories evaluated including overall top 3 category
- Top 10 Challengers: We create this list using the same methodology as the ITS Top 20 list. This list recognizes the top 10 service providers with annual revenue of less than US\$2 billion

Note: The analysis for the PEAK Matrix Service Provider of the Year is based on PEAK Matrix assessments conducted for the segments we assessed in 2022. This ranking/analysis is not indicative of the overall capabilities of service providers for segments of the IT services market that we do not assess. 



PEAK Matrix Service Provider of the Year: ITS Top 20




PEAK Matrix Service Provider of the Year 2023: Top Leaders and Star Performers


PEAK Matrix Service Provider of the Year Awards 2023: Key highlights




- Top of the leaderboard: Accenture retains its position at the top of the leaderboard
- Top 3: Accenture retains the top position in the list, TCS and Capgemini rose to the second and third
 positions respectively
- Moving up the ladder: 8 service providers improved their rankings
 - TCS moved from 3 to 2
 - Capgemini moved from 6 to 3
 - Wipro moved from 7 to 4
 - NTT Corporation moved from 9 to 8
 - Atos moved from 12 to 11
 - Deloitte moved from 13 to 12
 - Tech Mahindra moved from 14 to 13
 - Zensar Technologies moved from 18 to 17
- New entrants: EY, EPAM, LTIMindtree¹, and Orange Business Services entered the leaderboard this year
- Exits: UST Global and EXL exited the list
- **Overall:** 8 service providers improved their rankings, 5 service providers slipped, 3 service providers maintained their rankings, and 4¹ service providers entered the list
